

STATEMENT OF GENERAL TERMS & CONDITIONS

Fee Structure

All services, including hair products and supplies (excluding headpieces, hair accessories, and/or flowers) used for hair styles by professional, are included in the prices below. All hair must be clean and dry unless you are getting a blow dry (use little or no conditioner). Please do not flat iron your hair if you are having an up do (unless your hair is very curly or textured).

Down Style	Down style on clean, dry hair	\$75
Up / Half Up Style	Up or Half Up style on clean, dry hair	\$100
<i>Service for Bridal Party*</i> <input type="checkbox"/>	<i>Description of Service</i>	<i>Cost</i>
Attendant (Up-Style)	Up style on clean, dry hair	\$60
Attendant (Basic Style)	Blow Dry and Curl Iron or Flat Iron	\$50
Attendant (Curl)	Curl on clean, dry hair (up to 3 inches in length)	\$30
Flower Girl (12 or younger)	Curl on clean, dry hair	\$25
<i>Extra Charges</i>	<i>Description of Service</i>	<i>Cost</i>
Thick / Long Hair	Extra cost for excessively long, thick or curly hair.	\$25
Blow Dry	Extra cost if hair requires blow drying before styling.	\$25

*The minimum value of services required to reserve Bridal Party Services varies based on time of day, location, and number of attendants. Final costs will be negotiated prior to service scheduling.

Trial Service

\$50 per hour is the rate for trial services if they are performed at Natalie's home. If hair trial is not performed at Natalie's home and travel is required, then the rate is \$75 per hour.

Fee for Services

A **non-refundable, non-negotiable** deposit of **\$25.00** for each attendant including the bride is required at the time of booking and will be applied to the total payment. **All deposits to hold wedding date must be received at the time of scheduling services for your wedding day.** Other possible expenses to consider include hair extensions, hair accessories, jewelry, and flowers. **Travel Expenses will be negotiated prior to services.**

Payment for Services
